The Capitalization Fee for 2024 is \$850.00 plus 100% of the Service Area Assessment rate, if applicable. The Capitalization Fee is

					payable to the Association on the date of the transfer of title to a Lot. Some exemptions apply. For future years, the Capitalization Fee amount must be confirmed with the Association.
Foundation Section F]	Fee	[Declaration	Article	XV,	The Foundation Fee is charged to the Grantor and is due on the date of transfer of title in an amount equal to 50% of the then-current Annual Assessment rate. The Foundation Fee for 2024 is \$425.00. Some transfers are exempt, as provided in the Declaration. For future years, the Foundation Fee must be confirmed with the Association.
